Advent 3 - December 16, 2012 Sermon in the Aftermath of the Tragedy in Newtown, Connecticut

I wrote a sermon earlier this week, a sermon that followed the propers for Advent 3. But, given the unfathomable horror of Friday, it seems inappropriate to preach that sermon; because today, we find ourselves trying to wrap our minds around the unthinkable actions of an individual whose actions forever altered the lives of so many.

The first question that comes to everyone's mind is WHY? Why did this happen? And the truthful answer is: no one except God can answer that question. Regrettably, there are well intentioned people who are saying it was God's will. I have unfortunately heard this several times. And I am here to tell you nothing could be further from the truth! It was NOT God's will for this to happen to the innocents. That is not the God of my understanding. The Episcopal understanding of God is this: God is love. And all life is precious to God, because God created those lives. And the God of love does not will such devastation.

After WHY, the question I have heard most often is Where is God in the midst of this tragedy? I believe, to the deepest fibers of my being, that God is here.....in this place with us as we pray; and with all who grieve the loss of their loved ones. I believe God is in every tear that is being shed; and I believe God wept too on Friday.

Our emotions and reactions have run the gambit; from shock to disbelief to anger and to rage. And I want you to know these are normal feelings and it's OK to be having these emotions. It's part of how we try to wrap our minds around the unthinkable.

As we move through the emotions of the coming days and weeks, if you would like to talk with either me or Father Farrell, know we are here for you; and will give you a safe place to express your

For now, please continue to pray for those who need our prayers, and May light perpetual shine upon those who have gone to God; and may their souls through the mercy of God rest in peace. AMEN

THE CURATE'S COLUMN

Church and State



Formally, "the separation of church and state" is a reference to the first amendment to the constitution, which states that "Congress shall make no law respecting an establishment Amendment specifies that *no religious test shall ever be required* as a qualification to any office or public trust under the United States." That is, unlike the United Kingdom, which has a national church (known as an *established* church), The Church of England, the government cannot establish a national religion, nor can it prevent people from exercising their religion, as long as it does not conflict with the law. Article VI of the Constitution, on the other hand, prohibits requiring that federal employees subscribe to a certain faith. This contrasts with 17th and 18th century England, where the Test Act mandated that all government officials be members of the Church of England. This was primarily to

exclude Roman Catholics and nonconforming Protestants from holding office.

The phrase, "the separation of church and state," is nevertheless often cited to claim a much broader distinction between the two entities than is the case. Contrary to what many assume, a senator may legitimately cite his or her own religion as a reason for voting a certain way in congress. Prayer at the opening of congress also does not violate the Constitution. Even "In God we trust" on money cannot be said to be in violation in that it does not establish any specific religion as that of the nation. (Atheists can argue on moral grounds, however, that it violates their sense of belonging to the nation.)

This misunderstanding of the extent of the separation too often contributes to the clergy's abandonment of their responsibility to speak out on matters of ethics. It is the duty of clergy to address social ills and to advocate for justice. For this reason, for example, the Diocese of Long Island voted in support of a resolution "Concerning Support for Occupy Wall Street and All Peaceful Movements for Economic and Social Justice" at the 2011 convention: "BE IT RESOLVED that the 145th Convention of the Diocese of Long Island supports the October 23rd resolution of Executive Council stating that 'the growing movement of peaceful protests in public spaces in the United States and throughout the world in resistance to the exploitation of people for profit or power bears faithful witness in the tradition of Jesus to the sinful inequities in society' and calling upon 'Episcopalians to witness in the tradition of Jesus to inequities in society." In a similar vein, the U.S. Conference of [Roman] Catholic Bishops opposed Paul Ryan's budget proposal. In one of a series of letters sent to congressional committees, they stated: "I write to urge you to resist for moral and human reasons unacceptable cuts to hunger and nutrition programs [that would] hurt hungry children, poor families, vulnerable seniors and workers who cannot find employment. These cuts are unjustified and wrong."

If churches wish to maintain their tax-exempt status with the IRS, however, certain limitations must be observed. The IRS exemption requirements for 501(c)(3) organizations states that churches, "may not attempt to influence legislation as a substantial part of its activities and it may not participate in any campaign activity for or against political candidates." Support from the pulpit or in church newsletters for

a candidate would clearly violate Internal Revenue Code. A church may, however, attempt to influence legislation, but that must not comprise "a substantial part of its activities." What would constitute "substantial" is somewhat gray. This is still governed by a 1934 regime which "applies facts and circumstances criteria to determine substantial part." In other words, the IRS would look at the overall activities of the church and decide on a case-by-case basis. As a church, we must advocate for justice in the world. If we do not, we are ignoring our responsibility to our brothers and sisters.

SIGNS THE SEAS ARE PICKING UP

Notes from last departure from the Beaver Inlet.

Main Gas Turbine begins to hunt slightly as propeller lifts higher in water with quartering sea. CO desk makes this weird, rocking, thunk-thunk noise.

Bilge keels begin rolling out when she goes into the trough, roll back with a muffled "boom!" Chairs begin to drift away from the cabin table.

Hand soap on head sink dives into sink.

HF whips on forecastle begin to hum. Forward sewage bilge flooding alarm triggers.

Really heavy weather? Desk clears itself.

Secured in/out boxes empty themselves all over the deck.

Bridge head gets frequent, rapid use, often audible from the cabin.

Cabin chairs all lay flat, then roll around.

HF whips shimmy back and forth up to one foot at bridge level.

After a few hours, water intrusion triggers out one of the ship's general alarms (chemical or collision so far), blocking ability to pipe "stand down."

Occasional seas slap side of hull, flooding up to)-2 deck.

Everyone looks like zombies and climb their way around, moving only one limb at a time.

Maximum witnessed roll this tour? 45 degrees, Bering Sea, SAR case 2011.

Worst sustained seas: probably three days in Gulf of Alaska, October 2012.

Even most likely to foul laundry: stepping out on bridge wing to gauge coming about while escorting fishing vessel through "Storm of the Century," seeing following sea looming about height of stacks.

ISAAC HENRY GREEN SARAH AMELIA SNEDECOR GREEN Section 34 – Lot 4

Sayville lost one of its outstanding and most respected citizens on February 2nd, 1907, when **ISAAC** "**HENRY**" **GREEN**, **SR**. died. Henry Green, born December 6. 1827, was one of thirteen children born to Isaac Green and Charity Newton Green. Of these children, two died before reaching adulthood. The grandfather of this family, Willett Green, a Quaker, was an early settler of what is now Sayville, along with John Edwards. After the Revolution, Willett Green purchased, for 500 lbs, half of this land, which he had farmed as a tenant, from the British patent, of the Nichols family. As his five sons reached adulthood, Willett gave a piece of the land to each one. Some farmed; Henry did farm, but he also managed some of the property as real estate, and soon made a success of this.

Aside from a few years spent in the menhaden and fish oil factory business with his brothers, I. Henry Green kept his interests in Sayville. He married Sarah Amelia Snedecor, daughter of Captain Isaac Snedecor of Bayport, and fathered a son, Ralph C. Greene, who became a noted and prosperous lawyer, and a daughter, Lila.

Henry Green was a Warden of St. Ann's, he and his brother, Samuel Willett were on St. Ann's first Vestry. Henry's nephew, Isaac Henry Green Jr., Son of Samuel Willett Green, joined with his father and uncle on St. Ann's Vestry. The Greens were important, in that they helped in the growth of the church, particularly in the community.

Isaac Henry Green's funeral was a moving event, led by one of his closest friends, the Reverend Mr. Prescott, who preached the sermon at the deceased's home on Candee Avenue. Mr. Green was then interred in St. Ann's Cemetery.

Sixteen years later, in May of 1923, **SARAH AMELIA SNEDECOR GREEN** joined her husband. She died at the home of her daughter, Lila Robinson, in Babylon. A quiet funeral, conducted in the Robinson home, attended by her children Lila and son, U.S. District Attorney, Ralph C. Greene. She joined not only her husband, but many of her family and friends who were by then deceased.



THE EPISCOPAL FLAG



We see the flag every Sunday in church, but as so often with things that are constant in our lives, we do not really see it. I was surprised to find out recently that the Episcopal Church flag actually has its roots in the Diocese of Long Island, and the original flag now rests in the Undercroft of the Cathedral of the Incarnation in Garden City! It was designed by William

M. Baldwin, a diocesan delegate to General Convention. The original was sewn from a child's bedsheet. You can read the entire story from The Diocesan Archives, http://www.crwflags.com/fotw/flags/rel-epis.html.

The red cross is a Christian symbol dating back the the third century. The white represents purity, and red the blood of Christian martyrs. The blue recalls the clothing of the Virgin Mary and represents our Lord's human nature. The nine mini-crosses in the corner represent the nine dioceses that met in Philadelphia in 1789 when the Constitution of the Protestant Episcopal Church was adopted. These crosses are set in the form of a St. Andrew's cross (X) to remind us that our first bishop, Samuel Seabury of Connecticut, had to go to Scotland (St. Andrew being the patron saint of Scotland) to be consecrated by Scottish bishops so as to avoid dealing in any way with the British Royal Crown.

Next time you see the Episcopal flag on the altar or in the Parish Hall or see the Episcopal shield, take a second look and be reminded of our history. -Rodney Dudley
