FROM THE EDITOR

A habit is neutral. You lay down the pattern, and a few days—or a few years--later it's automatic. But watch out which habits you cultivate! An anonymous author writes this:

I am your constant companion. I am your greatest helper or heaviest burden. I will push you onward or drag you down to failure. I am completely at your command. Half the things you do you might just as well turn over to me, and I will be able to do them quickly, correctly. I am not a machine, though I work with all the precision of a machine plus the intelligence of a human being. You may run me for a profit or turn me for ruin—it makes no difference to me. Take me, train me, be firm with me, and I will place the world at your feet. Be easy with me, and I will destroy you. Who am I? I am habit.

Let's take this time in Lent to weed out our bad habits and build good ones.

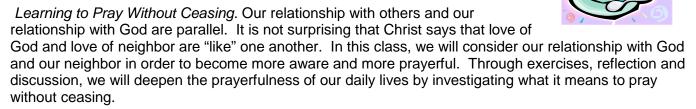

Vestry Visions

I have always known that Saint Ann's has a rich history. I have also believed that St. Ann's has been important in and to the local community. Yet over the past month, I have been awed by the role that St. Ann's has played for over 220 years. Our involvement in the local area and our history of caring were highlighted to me through three channels.

As I helped to prepare several grant requests for funds to help repair our church belfry, I learned more about the early history of St. Ann's and the influential citizens who made our stone church and lovely parish grounds a reality. There were the Suydams and their generous support in the earliest years of our parish and the Roosevelts who sat on our Vestry. The list of those who were part of our history reads like a who's who of the high society of the day. Yet these were not just people of means; they were people who cared for the welfare of our community. Our rector, the Reverend Mr. John Prescott, was involved in other areas of community life such as serving as a charter member of the Sayville Hook and Ladder Company and establishing the first lending library in Sayville (1880-1886).

In Jack Whitehouse's fascinating book Sayville Orphan Heroes: The Cottages of St. Ann's, I read of the generosity of Ida Gillette, a prominent member of our parish and community, and how she donated the gift of land on the south side of Middle Road for the Cottages. Then, through the 1920s into the early 1940s, the Reverend Joseph Bond was the spiritual leader and advisor for the children living in the Cottages which were facilities under the auspices of the Episcopal Church Charities Foundation.

Recently we held a ceremony to memorialize Nannie Dillard, a young black woman who died in 1898 and is buried in our cemetery. Connie Currie spearheaded the program; Alan Fricke Memorials donated her tombstone; Fr. Farrell spoke movingly about Nannie's story of grace and sadness. The role of St. Ann's in hosting such a moving event again reflects our compassion and our leadership in the community. Speaking to a local reporter, Connie captured the essence of what we at St. Ann's believe: "Life isn't based on class systems." Speaking of the event, Connie said, "In a small way, as a church, maybe it will do something, but in the meantime she has a marker in the cemetery. She's in there with the Roosevelts..."

In his history about the Cottages, Jack Whitehouse underscores the role of St. Ann's "strong spirit of charitable giving and civic responsibility." These are part of our essential fabric. They might make us proud, but they must make us determined to continue our legacy of charity in all senses of the word.

THE SEARCH FOR A NEW RECTOR: KICK-OFF DAY

On Saturday, January 29, 2011, the Discernment, or Search, Committee and the Vestry met with Facilitator, the Rev. Dr. Bruce Griffith, who will be easing us through the search process for choosing a new rector for St. Ann's. I am not actually a part of the Search Committee. I am part of an offshoot called the Writing Committee, which has as its project to create a tri-fold pamphlet which will encourage the world to beat a path to our door. We have our work cut out for us!



Fr. Griffith began by saying that what we focus on becomes reality. This means, of course, that we must be very intentional about what we focus on! If we choose to focus on having a tall blond who speaks Finnish, that may be what we get—but it won't necessarily meet the needs of this parish. In a similar vein, he urged us to accentuate the positive—what's right at St. Ann's--rather than avoiding the negative—trying to fix what is wrong or has been wrong in the past. By the end of the meeting, it was obvious to all that St. Ann's has a wealth of positives to offer any potential candidate.

For those who remember the previous process for choosing a rector, things have been changed (as they always are), so this time it will be a somewhat different experience. On the surface, my impression was that it will be somewhat like *American Idol*, with hordes of people lining up (figuratively, if not literally) at our door with the goal of becoming the next Rector of St. Ann's. The Search Committee would be the panel of judges. After a broad winnowing process, to determine which of the hopefuls has the wherewithal to achieve this goal, the candidates are narrowed down (*You're going to Hollywood!*) to a smaller number, who will be more rigorously examined. We then, after a series of hurdles (and perhaps valorous deeds), arrive at the top 3 or so, who will be considered by the Vestry. No, the congregation does NOT vote for candidates on their cell phones. Of course, this metaphor does not take into account the movement of the Holy Spirit among us, leading us to discern what the Lord wants for us. It is, after all, a calling and not a talent contest. However, like the TV show, this will not happen overnight. It will take weeks and months of discussion, research, and prayer, but we will try to keep you generally informed along the way as to the progress being made. At the end of the road, we plan to be welcoming a new rector who will be the one who is right for St. Ann's.

Let us all continue to keep the church in our prayers as we go forth on this important mission.

THE CURATE'S COLUMN



Choosing a Lenten Discipline



The season of Lent corresponds with the time Christ spent agonizing in the Garden of Gethsemane over his impending death. There, Christ prayed that his fate be taken away from him, but eventually was able to say, "Not my will, but Yours be done." Christ's ultimate acceptance of his death was a witness to integrity, love, responsibility and relationship with God. In Christ's struggle, we therefore recognize that it is not always best to choose the easiest route. In such cases, taking the easier path, as tempting as it may be, leaves us with a hollowness as we sense (consciously or not) that we have lost the most important thing in life in order to avoid difficulty. This is not an easy lesson

to learn. Escape is much easier in the moment. Following through requires the development of a larger vision.

As a spiritual practice to aid in learning this lesson, it is common for Christians to "give up" something during Lent. That is, we deprive ourselves of something to help us to understand that sometimes we have to forgo the easier path in order not to lose our integrity, that is, in order not to lose our ability to be fully present to God, to others, and to ourselves. We should choose what to do during Lent in the light of this practical goal. I knew people in seminary who chose to give up chocolate simply because they knew they would miss it. The point of Lent is not to suffer for the sake of suffering. It is instead to learn that circumstances sometimes force us to suffer if we are to remain true to who we are in relation to God. Others I knew in seminary gave up eating desert altogether because they wanted to diet. This, too, ignores the goal of a Lenten discipline; it lacks a spiritual component.

Once we grasp the goal, we realize that one need not "give up" something, but may instead "take on" a discipline. One year, for example, I took on the discipline of expressing my anger. Most of my life, I had taken the easy way out and suppressed legitimate anger in order to avoid the uneasiness of conflict. Unfortunately, I had thereby lost touch with what God was saying to me through that anger. I had been ignoring God for the sake of comfort—exactly what Christ refused to do in Gethsemane. About three weeks into my practice, a group at lunch began to discuss how their Lenten disciplines were going. I pronounced myself a Lenten failure (because I still was unable to express anger). One of the professors wisely admonished, "It's too early to tell." Indeed, Lent was not over, and the point of taking on a discipline is to grow over time. Even Christ, as he struggled, waffled back and forth before he came to terms with his situation and was able to accept the will of God.

In determining one's own Lenten discipline, one should remember that Christ's suffering was not arbitrary, but quite meaningful. It was not sought out, but thrust upon him by a world that was threatened by his message of love. So, one should take on something that will encourage one to grow in relationship with God. This could be any number of things, as varied as the number of people on the globe. What is it that keeps you from hearing God's voice? Is it constant busyness? A life filled with clutter? Fear of something? Where are you taking the easy way out, only to lose sight of the connection between you and God? When you find that, you will have found the beginnings of a meaningful Lenten discipline.

Remembering Nannie Dillard

Sermon preached by Fr. Farrell Graves on February 6, 2011, the occasion of the dedication of a tombstone for Nannie Dillard's grave, unmarked in the Garden of the Unforgotten for over 100 years.

We are here today in part to give thanks for Nannie Dillard and to complete something that was begun over a hundred years ago. The story of Nannie is one of great grace and great sadness. Widowed at 23 and forced to seek work far from home by an economic system that sees only profits, not people, she came to Sayville, a vacation resort at the time. People in those days would come to work in the hotels—the Elmore, the Hamlyn, the Kensington, and many others—in the summer and would go down to Florida to work there in the winter. Back and forth they went. Back and forth. Imagine trying to nurture your family, trying to give your children the stability and sense of safety they need to thrive. Is it any wonder that Nannie left her only child in Virginia, as painful as that must have been? Sometimes love and circumstances force us to make painful choices.

Nannie, moreover, never made it to Florida in the winter. She died here in Sayville in late August, 1898, a few months after her arrival. We know from her obituary that the guests of the Delavan Hotel where she worked near St. Ann's on the west side of Foster Avenue bore the cost of her illness and funeral. Fr. Prescott, who at the time would have been called the Reverend Prescott, the Rector of St. Ann's, opened the church for her funeral and the cemetery for her burial. The obituary tells us: "Many people, not only of her own race but also of ours, were present at the church and at the grave." It makes one a little uncomfortable, does it not, that people were seen almost as a different species? Still, even allowing for self-congratulatory journalistic hyperbole, it seems that the community here in Sayville treated Nannie well, and despite her difficulties, she was "a woman sweet in gratitude" and of "gentle disposition," according to the obituary.

Being sweet and gentle, however, could not shield her from the harshness of the economic system. One must wonder if the stress of Nannie's circumstances did not contribute to her weakened condition that ended her life at 23; and how did her husband die? Was it work related? When I taught English as a Second Language in Orange County, California, to migrant laborers, they told me that they were always given the most dangerous jobs. One day, I noticed that one of my best students was missing. I found out that he had fallen from a 15-foot wall onto a cement slab. He had survived, but was broken up. Not so long after that, in the pouring rain, he came hobbling to my classroom before class began. He could walk, barely, but was bandaged and splinted on his upper body and head. He explained that he could not stay for class because he could not focus—he was on strong painkillers—but he did not want me to think that he did not want to come to class. We need not wonder what the cause of Nannie's circumstances was. It was an economic system whose very structure was uncaring and unjust.

We have the tendency to sanctify whatever system happens to be in place, to justify its outcomes, to ignore its toll on human beings. I remember when my father was laid off after many years of faithful service to a company. He had been there the longest, was the highest paid, and so he was the first to go. My uncle told him that he had read an article in the *Wall Street Journal* and that what had happened was "just good economics."

It might be good economics, but that does not make it just. Christianity demands more than simply following the rules. "For I tell you, unless your righteousness exceeds that of the scribes and Pharisees, you will never enter the kingdom of heaven." The conditions that forced Nannie to leave her home to wander about the country from job to job were unjust. I am glad that she found herself in a caring community that went beyond what the system demanded.

Our society invites us to conceal injustice from ourselves and presents us with methods for doing that. We can use categories like black and white to conceal economic abuse behind rhetorical prisms that prevent us from seeing people. Racism, sexism, and homophobia are used to further political and economic agendas that are far from the love and grace that Christ preached. He said love your neighbor as yourself, no exceptions. Some of our parishioners recently were scandalized to discover that female rectors are paid less than male rectors for the same work. So, if you want a bargain, hire a female—and this is within the church.

And all of use are affected by this prism no matter what our experience or what our ethnicity, gender, sexuality. I lived many years in California, where one only saw Latinos stocking shelves, and then I moved to Manhattan, where that work was done primarily by people of African descent. I then visited my friend at a seminary in a remote region of Tennessee, where I saw white people stocking shelves, and I, even I who have lived my whole life on the margin, took note. And in that "taking note," I realized that even I have been trained to have certain expectations. I realized that I had drunk in poison unintentionally. We must be vigilant if we are to love as radically as Christ calls us to love, and we must support each other in that love. We cannot do it all alone.

The circumstances that Nannie faced are very similar to those of migrant laborers in Long Island and throughout the US to this very day. I preached two weeks ago about the head of Chaplaincy at my university's hospital denying me the privilege of visiting those who had AIDS. What I did not tell you at the time was that I persevered and found a secular organization that was formed to do just that. There, as a "buddy," I met a migrant laborer in the hospital. He had AIDS and tuberculosis. He told me that he followed the crops, from Florida orange groves up the coast to the cucumber fields of the eastern shore of Virginia. He dreaded going back to the work camp because everything that he owned, everything but the clothes he was wearing when he was brought to the hospital, would have been stolen from the shack in which he slept by other desperate people. Now long dead, he did not find the kind of loving community like that in which Nannie thankfully ended her days. He was completely alone in the world and was surely buried in a pauper's grave and forgotten. Few receive the kindness and attention that Nannie did.

There was an article in the *New York Times* last December about the plight of migrant laborers on Long Island. It said that they suffer from a high rate of tuberculosis. They also face violence. In fact, it was not long ago that one such person was murdered in Patchogue. And once their work here is finished, then they must move down the coast as winter approaches. This life provides no stability, no security, no community, but it is, I'm sure, "just good economics." Given the many justifications we have for exclusion and for turning a blind eye, Nannie's treatment was indeed remarkable.

Sometimes Christianity is used to lure us to sleep, into feeling comfortable in our promise of salvation and our rectitude, but sometimes it works, sometimes it encourages us to be our best, to take risks, to love. We see an example of this in Nannie's story. And what of Nannie herself? To have remained "sweet in gratitude" and of "gentle disposition" under the circumstances in which she lived, to have drawn community around her as she did, Nannie must have indeed been a remarkable person.

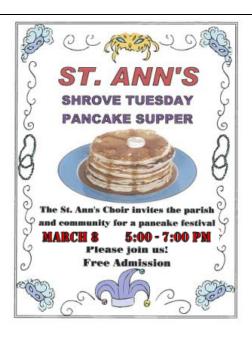
St. Ann's stood with Nannie then. Let us stand with all our brothers and sisters now. This beautiful story from the past calls us to do beautiful things now. We are on our way here at St. Ann's. We are on track. The Rev. Prescott would be pleased. Opportunities to love will come to us, and we have to be ready to seize them, to exceed what our society tells us is acceptable, prudent, and appropriate, so that 100 years from now, when they read about us, they will have the same feeling that we have when we read about Nannie Dillard.

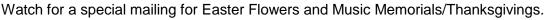

Captain William T. Collins

Lot 3 – Downs & Collins Plot

Captain William T. Collins, born in Sayville on July 9, 1886, the son of Daniel and Martha Rhodes Collins died at his home on Collins Avenue at 5:45 on November 7, 1939. All his life had been spent here. Few of many men knew the Great South Bay better. He was a fireman most of his days and a successful one. For 25 years he was sailing master, handling the yachts of the late Frank S. Jones.

He was a handsome man, very popular, had been an active volunteer fireman, and if he had lived until the first of the ensuing year, he would have been accorded special honors by the department for his 50 years of service. He had been a member of Sayville Lodge I.O.O.F. during most of his adult life. Captain Collins enjoyed almost perfect health until he suffered a stroke six months prior to his death.

Surviving the Captain were his wife, two sons Leslie and Harold, and a daughter, Mrs. Roland Smith, who traveled from Miami to attend the funeral. He had nine grandchildren. He also left an older brother, Captain Daniel Collins, also a lifelong bayman, and a sister, Mrs. Symes Murdock. The funeral service was conducted by the Reverend D. Paul Herriot, pastor of the Sayville Congregational Church, with the burial following in St. Ann's Garden of the Unforgotten.
